

County Executive Angela Alsobrooks & Mistress of Ceremonies Angela Stribling



In November 2018, Angela, a proud, life-long Prince Georgian, was elected as the 8th County Executive for Prince George's County and the first woman to hold the position. Her administration is committed to providing a world-class education system, safe communities and a robust economy that creates jobs and opportunities for all and increases the commercial tax base to ensure residents are provided with the services they deserve.

After graduating with her B.A. in Public Policy from Duke University and her J.D. from the University of Maryland Law School, Angela began her career as a Prince George's County Assistant State's Attorney in 1997, eventually becoming the county's first full-time prosecutor assigned to handle domestic violence cases.

In 2002, Angela was appointed by the County Executive to serve as Education Liaison, where she organized educational forums to help increase parental involvement in schools and environmental-based learning opportunities. In 2003, she was appointed the Executive Director of the county's Revenue Authority. Under her leadership, the agency increased revenue by 40% through their parking enforcement program and some of those funds were used to help the county maintain a balanced budget during the recession.

In 2010, Angela was elected to serve as the county's State's Attorney, becoming the youngest and first woman to be elected to the office in Prince George's County.

As the county's top law enforcement official, Angela played a key role in public safety and strived to carry out her responsibilities in a firm, fair and consistent manner. She fought for additional resources to ensure the office could appropriately support the needs of the community.

She created a truancy reduction initiative that works with schools to keep kids on the right path and also started a program called Back on Track – Prince George's, aimed at giving first-time, low-level, non-violent, felony drug dealers a second chance in the community. Under her leadership, prosecution rates rose across the board and remained steady during her tenure.

Angela is a member of the First Baptist Church of Glenarden and Delta Sigma Theta Sorority, Inc. and is involved in the effort to raise breast cancer awareness in her community. Angela resides in Upper Marlboro with her daughter, Alex.

# President and CEO, National Coalition on Black Civic Participation

Melanie Campbell is President/CEO of the National Coalition on Black Civic Participation and convener of the Black Women's Roundtable. Campbell is one of the hardest working leaders in today's Civil Rights, Women's Rights and Social Justice Movements. She recently celebrated 25 years of service with The National Coalition and has served as an advisor on critical social issues to U.S. presidents, congressional members, executives, philanthropists, faith leaders and others.

Campbell is dedicated to mentoring the next generation and counts among her most rewarding accomplishments creating initiatives like the Black Youth Vote civic leadership and organizing program at The National Coalition. She is also committed to lifting up Black womens' leadership in social justice and has made this aim central to her life's work, through the Black Women's Roundtable.

She is a veteran coalition builder and is highly successful in leading civic engagement, voter empowerment and issue-based campaigns. Campbell releases an annual Black Women's Roundtable Report on the status of Black women during the BWR Women of Power Summit that celebrates Women's History Month, and presents an annual public policy agenda to members of Congress.

Campbell has served as a featured writer for the National Urban League's State of Black America and is regularly featured in ESSENCE, Washington Post, USA Today, and more. In March 2020, she was awarded the "Sustainer of the Flame Freedom Flame Award" by The Bridge Crossing Jubilee during the 55th Anniversary of Selma to Montgomery.

A native of Mims, Florida, Campbell has a B.A. in Business Administration from Clark Atlanta University and a certificate in non-profit executive management from Georgetown University. She is a member of the Inaugural Class of Progressive Women's Voices at the Women's Media Center and resident fellow alumni of the John F. Kennedy School of Government at Harvard University.

# Next generation McDonald's franchise owner

Imani Ford is a part owner of a McDonald's and is in the process of becoming a second generation McDonald's owner-operator. Imani's family business, Hopkins Navies Management, Inc., owns and operates eight McDonald's Restaurants in Prince George's County. They have owned McDonald's restaurants for over 25 years. Imani understands the importance of building generational wealth within the Black community, and believes "We must ensure we have a seat at the table so future generations can be game changers within any industry of their choosing."

Prior to returning to Prince George's County for succession training, Imani graduated from Spelman College, where she received a Bachelor of Arts degree in English. After graduation, Imani became an Account Executive with Moroch Advertising Agency, overseeing both the Atlanta, Georgia and Augusta, Georgia McDonald's markets.

In addition to pursuing her quest to be a McDonald's owner, Imani currently serves on the Board of Planned Parenthood of Metropolitan Washington DC. She resides in Prince George's County with her husband, Kevin Ford, Jr., and their son, Kevin, III.



# **Deirdre Stanley**

Executive Vice President and General Counsel, The Estée Lauder Companies Inc.

Deirdre Stanley is Executive Vice President and General Counsel of The Estée Lauder Companies (ELC). In this capacity, Ms. Stanley leads the company's legal strategy, practices and policies, and is responsible for ELC's Legal organization globally. Maysa's unique, instantly identifiable vocal sound encompasses both Jazz and R&B, and, according to one critic, "will inspire young and old alike to slow dance with their boo." Grammy-nominated, Soul Train Award Winning singer Maysa celebrates her 29th year as a recording artist and 25th year as a solo artist in 2020.

Born and raised in Baltimore, Maysa Leak knew early on that she would be a musician. "I was six years old when my mom took me to see Purlie," she recalls. "When Melba Moore came on stage and sang her heart out, I knew at that moment I wanted to make people feel the way she made me feel."

Maysa started singing 25 years ago in Stevie Wonder's female backing group Wonderlove and later became the vocalist for British funk band Incognito. In 1995 she recorded her first solo album MAYSA, which debuted to rave reviews from critics and listeners alike.

Marissa Michel is the 2020 Prince George's County Youth Poet Laureate and a second generation American of Haitian and Puerto Rican heritage. She is a Scholastic national award-winning teenage writer, published author, and artist. Marissa is also known for being an outspoken advocate for women of color, immigrants, and underserved communities. Her writing tends to reflect diverse experiences of living in America and center on topics of gender, race, and class.

Marissa became a Prince George's County Youth Poet Ambassador at 13 and won 4 regional awards in the prestigious Scholastic Arts and Writing 2018 Competition. After winning a national silver medal in writing, Marissa won 16 more regional Scholastic Awards in 2019 in categories spanning short story, personal memoir, photography, and more. Her poem "Second Generation American" and flash fiction piece "Momma Likes my Hair straight" can be found in the latest release of Pen In Hand; the Maryland Writers Association Official Literary Journal.

Marissa is also a member of the Maryland Writers Association. As a sophomore, Marissa is the youngest head in the history of the Female Empowerment Mission (FEM) club at Sidwell Friends High School, co-founder/co-head of the Students for Art and Music club, a digital editor of the Quarterly Magazine, and a choreographer on the dance team. She raises awareness about underrepresented POC as well as the complexities of intersectionality through all aspects of her work. Last December Marissa flew to Seattle as a member of a selected group of students to participate in the 2019 "Student Diversity Leadership Conference" (SDLC).

Marissa is also a member of the first Diversity and Ethical Leadership Conference Planning Board at her school. Marissa is a multi-talented, dedicated, spontaneous young writer who overcomes obstacles and brings a clear, loud and innovative voice to every issue she tackles.

# **Pennie Abramson**

In over 40 years of non-profit leadership and philanthropy, Pennie Abramson has been involved in nearly every cause to enhance public welfare through the arts, sciences, humanities, education, and the protection and development of children.

A lifelong resident of Maryland, Pennie is also a natural coalition builder and prolific fundraiser who has provided significant support to numerous Democratic causes and candidates in local, state, and federal elections.

Pennie's dedication to humanitarian and social activism is reinforced by many decades of consistent service to the preservation and growth of the organizations she serves, including: the National Foundation for Missing and Abused Children (NCMEC), Friends of Cancer Research, The Heifetz International Music Institute, Operation Embrace, Project MediShare, and Save A Child's Heart.

In 2010 Pennie was awarded an Honorary Doctorate from The Weizmann Institute of Science for her exemplary dedication over 35 years of service to the advancement of Israeli science. She is currently President Emeritus of the American Committee and remains a member of the executive committee on the International Board of Governors as well as The Feinberg Graduate School of the Weizmann Institute of Science in New York.

Twenty-five years ago, Pennie became a founding member and the first Chairman of the Montgomery County Public School (MCPS) Educational Foundation, where she still Chairs the Small Grants and Scholarships committee. Most recently, in response to the COVID-19 crisis, Pennie co-founded Fisher Island Gives, an emergency response campaign to benefit residents of the Miami-Dade community which just made an inaugural gift of \$1 million to benefit Feeding South Florida and Lotus House Women's Shelter in Miami.

Pennie has been married to her husband Gary Abramson for 50 years. They have three children and 4 grandchildren.



# **Cora Masters Barry**

Professor and civic leader Cora Masters Barry was born in Oklahoma City, Oklahoma. She graduated from Texas Southern University with a B.A. degree, and subsequently earned her M.A. degree in urban studies and public administration from Howard University in 1972. In 1976, Barry began teaching political science at the University of the District of Columbia, where she specialized in teaching "Black Politics, Comparative Political Studies, the Presidency, and the Constitution." Barry also ran the voter registration drive for Marion Barry's 1994 re-election campaign and chaired his inaugural committee.

As First Lady of the District of Columbia, Barry founded the Recreation Wish List Committee (RWLC) in 1995 to support recreational activities and provide a nurturing learning environment for underserved youth in Washington D.C. In 1995, she co-organized the "Women for the Million Man March." In 2001, she founded the Southeast Tennis and Learning Center, a premier tennis and education facility.

Throughout her career, Barry has been the recipient of numerous awards, including the DC Chamber of Commerce Community Impact Award, being named the 2013 Washingtonian of the Year by Washingtonian Magazine, the USTA Founders Award, and the National Recreation and Park Association's Robert Artz Citizen Advocacy Award.

Currently in addition to her leadership of the Recreation Wish List Committee, Cora Masters Barry serves as President, Marion Barry Jr, Legacy Foundation; Commissioner, the DC Arts and Humanities Commission; Board Member, National Coalition on Black Civic Participation; and Podcast Host, Nothing New Under the Sun.



# Dr. Rev. Gwen Boyd

Gwendolyn Elizabeth Boyd is an engineer, leader, speaker, preacher and STEM advocate. She earned a B.S. in mathematics from Alabama State University, received a fellowship and was the first African-American female to earn a Master of Mechanical Engineering from Yale University. She earned a Master of Divinity and Doctor of Ministry degrees from Howard University.

The highlights of Boyd's professional career at the Johns Hopkins University Applied Physics Laboratory were her work as part of engineering teams and her tenure as Chair of the Johns Hopkins Diversity Leadership Council.

Boyd returned to her alma mater and for three years served as the 14th and first female President of ASU. Nominated by President Barack Obama, she received Senate confirmation to serve as a trustee to the Barry M. Goldwater Scholarship and Excellence in Education Foundation and, later, on the President's Advisory Commission on Educational Excellence for African Americans.

She is an ordained itinerant elder in the African Methodist Episcopal Church and serves on the ministerial staff of Ebenezer AME Church in Fort Washington.

Boyd served as the 22nd National President of Delta Sigma Theta Sorority Inc. Known as the "Technology President," she established technology usage in all facets of sorority activities and administration. Some transformative accomplishments during her tenure included Project SEE (Science in Everyday Experiences); NGO status at the United Nations; and humanitarian efforts in Swaziland, Lesotho and South Africa.

A member of the Capital City Chapter of The Links, she has served on local, area and national levels and as Interim Executive Director.

Dr. Boyd has received numerous awards for her accomplishments: four honorary doctorates; The Carver Medal from Simpson College; Chancellor's Award, from NCCU; Chairman's Award, NBCA Hall of Fame; President's Award, Black Women's Agenda. She is a member of Leadership Greater Washington and serves on the Board of Directors of MedStar Health Systems.



# **Janet Cook**

Janet Stevens Cook has been a self-established entrepreneur for over 25 years. She was raised in Freeport Long Island, New York where she immersed herself in the arts by acting, modeling, and dancing. She attended Howard University, pledged the Delta Sigma Theta sorority, and graduated with a B.A. in Marketing. After graduation, she established multiple cuisine and juice bars before launching Dignity Services Inc., a youth development foundation. As an advocate for workforce development, she wanted to ensure the fair treatment of workers by opening her own labor staffing agency. In 2008 Janet published her first novel, "Black Sky." All the roads traveled by Janet have enabled her to give back to others through Mediocrity is Not An Option, a motivational speaking series for women designed to awaken the audience to their God given destinies and encourage them dedicate to a journey of self-discovery that will allow them to pursue a life full of purpose.

Janet is a widow and proud mother of two extraordinary children, Quinn and Kelsey Cook. Quinn resides in Oakland, CA, and is a two time NBA Champion, with the Los Angeles Lakers (2020) and the Golden State Warriors (2018), and an NCAA National Champion with Duke (2015). Kelsey resides in Los Angeles, CA where she is a member of the R&B group Cherry Bomb and the new CEO of Event Staff Inc. Janet believes her success as a businesswoman is rooted in her dedication and strong work ethic. She is proud that she has passed the torch of success to her children.



# **Kelsey Cook**

Kelsey Cook was born in Washington DC and raised in Prince George's County, Maryland. At a very young age, Kelsey was bitten by the entertainment bug. Starting off by taking tap and jazz dance classes, she began her modeling and acting career at the age of 15 and eventually placed as a runner up in the Miss Maryland Teen USA Pageant.

At the age of 16, Kelsey entered the professional music scene when she signed with Song records and began her solo recording career.
